#### **DESCRIPTION OF RAFFLE**

ESA All-Stars, the sponsor of this raffle, is offering the purchaser an opportunity to become eligible for a drawing for multiple prizes, including a **travel voucher and Amazon.com gift card**. Additional prizes may be added and determined as donor confirms them.

If fewer than 350 tickets are sold by June 1, 2016, the raffle reverts to a 50/50 raffle, with 50% of the raffle proceeds awarded to a single winner, in lieu of the other listed final drawing prizes described herein.

#### **HOW TO ENTER**

You may enter for a chance to win one (1) of the following items: **\$1000 travel voucher, \$500 Amazon.com gift card, one (1) \$250 Amazon.com gift card, one (1) Liquid Shredder surfboard, one (1) Rip Curl wetsuit, one (1) pair of Reflekt Polarized sunglasses or any additional items that the ESA All-Star Team deems appropriate for raffle**. You must be at least 18 years of age, or older on the date of raffle ticket purchase. The ESA All-Star Team is not responsible for printing errors in any drawing related material, or for lost, late, misdirected or non-delivered mail, or any other failure to receive orders or deliver receipts prior to the drawing deadlines. All entries become the property of the ESA All-Star Team and will not be returned.

All sales are final unless otherwise specified in these official rules. No raffle ticket refunds will be made. The ESA All-Star Team will reject any drawing ticket request if the check or credit card payment is not honored or any other reason prior and not remedied before the time of drawing. The ESA All-Star Team will not notify purchasers of an unsuccessful payment transaction.

Raffle ticket sales end at noon EST on September 24, 2016. All tickets purchased up to that time will be included in the final drawing.

#### **RAFFLE DRAWINGS:**

The raffle final prize drawings will be held live at The Easterns® on September 24, 2016 during the final awards ceremony. Raffle ticket sales are limited to 1,000, unless otherwise determined at the sole discretion of the ESA All-Star Team and its Committee.

Additional prizes may be added to the raffle; however, the raffle includes at least 3 prizes (so long as at least 350 tickets are sold). If less than 350 tickets are sold, only one winner will be drawn for a 50/50 raffle as described herein. **Note: If less than 350 tickets are sold, no travel voucher or Amazon gift cards will be awarded.**

Void where prohibited or restricted by law. All federal, state and local laws and

regulations apply. Each winner's name, ticket number, and town they reside in will be announced.

All winners will be contacted by phone, e-mail, and/or certified letter within 48 hours of drawing. Prizes may not be redeemed for cash or credit.

You must be 18 years or older to purchase raffle ticket. Winner must claim prizes within 20 days of the raffle drawing date.

To claim the prize, the winner will be required to provide proof of identity, sign an affidavit of eligibility/liability/terms and liability and conditions/publicity releases ("Release"), and complete IRS Form W-9, and any other forms required by law.

### **50/50 Cash Raffle Possible Outcome**

If the raffle outcome results in fewer than 350 tickets being sold by the June 1, 2016, the ticket proceeds are split 50/50 with the one drawn winner in lieu of the multiple prizes described herein.

The ESA All-Star Committee will first estimate, deduct, and submit Federal and State withholding taxes to the IRS from the 50% proceeds awarded the winner. Winner will receive a check for the remaining 50/50 prize money, after these deductions, and upon completion and signature of Form W-2G, Certain Gambling Winnings and Form W-9. The Foundation will submit the winner's W-2G and estimated Federal and State Withholding taxes on winner's behalf.

To receive any prize offered, you may not be required to: buy any goods or services, pay money (beyond the initial ticket purchase), or submit to any promotion.

### **WINNER NOTIFICATION**

The winners will be announced at the drawing by name and verified by matching the ticket number with the information provided in the records. All winners will be notified via telephone or email based on the information provided at ticket purchase.

If the winner does not respond within ten (10) days of raffle drawing on September 24, 2016, the ESA All-Star Committee will make one additional attempt to notify the winner via certified mail return receipt notification mail. Failure of the raffle winner to respond within 20 days of the raffle drawing date will constitute a forfeiture of the prize, and a new winner will be selected and notified.

The ESA All-Star Team is not responsible for any delays or obstacles in notification due to (a) erroneous contact information; (b) any outage or delay in Internet service or access; or (c) any other circumstances which may delay or prevent a winner from receiving the prize notifications. **Notice to the address provided constitutes adequate notice for these provisions**
